Cluster analysis Cluster analysis, or clustering, is a data analysis technique aimed at partitioning a set of objects into groups such that objects within the same group Cluster analysis, or clustering, is a data analysis technique aimed at partitioning a set of objects into groups such that objects within the same group (called a cluster) exhibit greater similarity to one another (in some specific sense defined by the analyst) than to those in other groups (clusters). It is a main task of exploratory data analysis, and a common technique for statistical data analysis, used in many fields, including pattern recognition, image analysis, information retrieval, bioinformatics, data compression, computer graphics and machine learning

Meta-analysis Meta-analyses are integral in supporting research grant proposals, shaping treatment guidelines, and influencing health policies. They are also pivotal in summarizing existing research to guide future studies, thereby cementing their role as a fundamental methodology in metascience. doi:10. An important part of this method involves computing a combined effect size across all of the studies. Dimensional analysis In this approach, one In engineering and science, dimensional analysis is the analysis of the relationships between different physical quantities by identifying their base quantities (such as length, mass, time, and electric current) and units of measurement (such as metres and grams) and tracking these dimensions as calculations or comparisons are performed. The term dimensional analysis is also used to refer to conversion of units from one dimensional unit to another, which can be used to evaluate scientific formulae. used in a way that is similar to dimensional analysis to derive more information about acceptable solutions of physical problems

It can be defined as "financial system instability, potentially catastrophic, caused or exacerbated by idiosyncratic events or conditions in financial intermediaries". At present, it is unclear how In finance, systemic risk is the risk of collapse of an entire financial system or entire market, as opposed to the risk associated with any one individual entity, group or component of a system, that can be contained therein without harming the entire system. It is also sometimes erroneously referred to as "systematic risk". It refers to the risks imposed by interlinkages and interdependencies in a system or market, where the failure of a single entity or cluster of entities can cause a cascading failure, which could potentially bankrupt or bring down the entire system or market

Cluster analysis refers to a family of algorithms and tasks rather than one specific algorithm. It can be achieved by various algorithms that differ significantly in their understanding of what constitutes a cluster and how to efficiently...
